Another Outstanding Year!

Another very successful year at your Co-op! Record earnings due mainly to the large grain dryer and record cold winter, which proved to be very profitable in our L.P. Department. All departments, with the exception of one exceeded last year's earnings. Non-member volumes were a large part of your Co-op's earning this year. Non-member business attributes a large part of your Co-op's financial stability and the ability to have good equipment to better serve all our member's and customer's needs.

This will be a year for our L.P. Department to remember after an extreme L.P. shortage in the Midwest. Your Co-op continued to deliver full orders of L.P., they increased their volumes and unlike most of our competitors did not exceed \$3.59 per gallon. Many retailers were over \$5.00 per gallon this past winter. Proactive planning allowed your Co-op to get through the shortage of the year and exceed our customer's expectations.

Your Crops Department experienced another nail biter. The season required a lot of adjusting and readjusting schedules for application of plant nutrients and crop protection products. Without a doubt, your Crops Department remained very flexible and committed to meeting your changing needs. Their dedication and service remained unsurpassed by other retailers. THANK YOU Crops Team and THANK YOU Members for your trust in us! Please continue to share your compliments, comments and concerns to your Crops representative or Crops Manager.

Crops inputs and protection products remain a 'flip of a coin' on what to expect for the next crops year with depressed grain prices. If the dollar continues to increase against world currencies and grain prices remain low, one would think the cost for crop inputs would adjust accordingly but currently the pipeline of products remains tight. Late harvest will probably make the demand very light this fall and intense for spring of 2015.

Petroleum remains a sizable cost to your operation. Many refined fuel inventories are at record levels including Propane. Although possible higher consumption for fuels this fall/winter are expected due to dryer gas, diesel for home heat in the east and propane heating is currently keeping prices stable for now. Propane prices are expected to increase once cold weather hits. Contracting fall and winter fuels could prove beneficial this year. After we see what the winter does with fuel inventories and how the dollar reacts this winter we can get a better handle on spring fuel contracting.

Your Co-op continues to be committed to serving your needs. Your patronage keeps us growing and succeeding with you. THANK YOU for your patronage. We will continue to make service our top priority.
